I/we understand that the cost for my family members listed above & me to become Full Members is a one-time equity payment of \$925, as well as each year's dues (\$500 in 2008). There is ONE waiting list for membership, in two parts: a waiting list & a list of the 30 Seasonal Members who are waiting to become Full Members. Seasonal Memberships (temporary steppingstone to Full Membership) pay 1/2 of the equity payment (\$465) plus the annual dues. Seasonal members who are current in their dues maintain their position until a Full Membership opens up. Seasonal members are required to upgrade to Full Membership by paying the remainder of their equity payment (\$460) as soon as it is offered, or risk termination of Membership & a \$100 deduction from their equity reimbursement. The Club keeps 5% of my equity payment per year, up to a maximum of 50%. If my dues are current when I resign, a portion of my equity payment should be refunded. Any remaining equity due to me will be refunded only upon the Club's resale of my membership.

We agree that, if we are accepted for membership, our family will abide by all rules, regulations and bylaws of the Club. We agree that our dues will be paid prior to May 1st each year, and prior to our use of the Club, and that the use of the Club's facilities by anyone other than those listed above (or paid guests) will subject us to termination or expulsion.
